As your incoming Chair of the Board, I am excited about the work that River Region United Way is doing in our communities.

I first want to thank Jason Goodson, who served as Chair of the Board in 2018-19. Under Jason's leadership, the Board of Directors welcomed new agencies into our affiliate network for the first time since 2006. These included the Cancer Wellness Foundation of Central Alabama, Hope Inspired Ministries, Legal Services Alabama and Butterfly Bridge Children's Advocacy Centers (Autauga and Elmore counties). In 2019, we partnered with United Methodist Children's Home, now operating Mary Ellen's Hearth at Nellie Burge, as well as Aletheia House, formerly known as Chemical Addiction Program. Most recently, we welcomed Service Dogs Alabama as our newest community partner.

In 2019, our work in education through United Way Days Of Action blossomed into a two-week summer reading initiative, partnering with an elementary school in Montgomery and adding another in Macon County. With the help of nearly 100 volunteers, we were able to serve more than 200 students and give away over 2,500 books to help stop the "summer slide" that many students experience, falling behind in their reading skills.

United Way is developing a more robust Community Needs Assessment process as we work to identify the most acute needs in our five-county River Region, as well as gaps in services. It is this process of identifying problems and working together to develop solutions that drives our work.

The Board of Directors began a comprehensive strategic planning process in 2019, and sought input and feedback through focus groups, online surveys and phone interviews to gather information from all of our stakeholder groups as we work to chart a path forward. We are excited about what lies ahead and look forward to sharing more with you in the months to come.

On behalf of the Board of Directors and CEO Jimmy Hill, we want to thank all of our community partners, volunteers and donors for your support. We know that when we all come together -- as problem solvers -- to address needs in our communities, then we truly can strengthen our communities and make life better for everyone.



## **Days Of Action**

Our annual Days Of Action project shines a spotlight on some of the basic needs in our communities, and encourages people to take action and make a positive impact by volunteering with River Region United Way. The purpose of the 2019 Days of Action project was to provide summer learning opportunities in a fun setting for pre-k to 6th grade children and to foster a love for reading early in life.

In partnership with the Macon County Board of Education, Montgomery Public Schools, EAT SOUTH and the Kiwanis Club of Montgomery, RRUW brought the "Can You Dig It?" summer reading program to Notasulga Elementary in Macon County and E.T. Davis Elementary in Montgomery.

Nearly **100 volunteers** assisted teachers with reading activities and learning games centered around good nutrition, healthy eating and learning about how our food is grown. The culmination of the summer reading camp activities was a field trip to EAT SOUTH, an urban teaching farm in downtown Montgomery. Volunteers presented **200 students** with backpacks filled with over **2,500 books** at the end of the week!


## In Memory of Joseph M. Russell, Jr.




